## SPECIAL ORDINANCE NO. 07-11-20

SPECIAL ORDINANCE AUTHORIZING THE MUNICIPAL MAYOR TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE BULALACAO DEVELOPMENT COOPERATIVE (BUDECO) GRANTING THE LATTER THE AUTHORITY TO AUTOMATICALLY DEDUCT FROM THE PAYROLL THE LOAN AMORTIZATIONS, CAPITAL SHARE AND OTHER FINANCIAL OBLIGATIONS OF THE MEMBERS PAYABLE TO THE COOPERATIVE

BE IT ORDAINED by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:


SECTION 1. The Municipal Mayor, Engr. Ernile C. Villas is hereby authorized to enter into a Memorandum of Agreement with the Bulalacao Development Cooperative (BUDECO) represented by its Manager, Mr. Dexter R. Gonzales granting the latter the authority to automatically deduct from the payroll the loan amortizations, capital share and other financial obligations of the members payable to the Cooperative;




SECTION 2. This special ordinance shall take effect immediately.


