**SPECIAL ORDINANCE NO. 07-09-13-A**

**GRANTING EXEMPTION TO THE PHILIPPINE PORTS AUTHORITY FROM THE PAYMENT OF REAL PROPERTY TAX, AMONG OTHERS**

**Sponsor: Councilor Gideon B. Abuel**  
**Co-sponsor: Councilor Leonardo A. Andallon**

**BE IT ORDAINED** by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:

**SECTION 1.** The properties currently administered by the Philippine Ports Authority in the Municipality of Bulalacao, Province of Oriental Mindoro are hereby granted exemption from the payment of real property taxation as contemplated under the ruling of the Supreme Court in the case of Manila International Airport Authority vs. Court of Appeals et al (G.R. No. 155650); Provided that all listed properties administered by the PPA within this Municipality are likewise dropped from the Assessment Roll and; Provided further that the Municipality shall continue to exercise its taxing power on any private persons, lessees or beneficial users of any PPA property which copies of contracts shall be furnished the Municipality;

SEC. 2. This Special Ordinance shall take effect immediately.


