SPECIAL ORDINANCE NO. 05-03-004

SPECIAL ORDINANCE AUTHORIZING THE MUNICIPAL MAYOR TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH BULALACAO MOTORCYCLE OPERATORS AND SINGLE ASSOCIATION, INC. (BUMOSINA) TO EXERCISE EXCLUSIVE RIGHT TO OPERATE, MAINTAIN AND COLLECT THE NECESSARY FEES FOR THE USE OF THE PUBLIC PARKING AREA SITUATED AT BARANGAY CAMPAASAN, THIS MUNICIPALITY

BE IT ORDAINED by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:

SECTION 1. The Municipal Mayor, the Honorable Ernilo C. Villas is hereby authorized to enter into a Memorandum of Agreement with Dennis M. Fajer, President, Bulalacao Motorcycle Operators and Single Association, Inc. (BUMOSINA) to exercise the exclusive right to operate, maintain and collect the necessary fees for the use of the public parking area situated at Barangay Campaasan, this Municipality;

SECTION 2. Mode of Payments. Payments of the rental fees for the grant of exclusive right be made in quarterly basis which should be ended on December 20, 2005;
