ORDINANCE NO. 05-06-049

ADOPTING AND FIXING A NEW SALARY/WAGE RATE OF CERTAIN MUNICIPAL EMPLOYEES ON JOB ORDER BASIS AND CLASSIFYING THEIR STATUS THEREOF

BE IT ORDAINED by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:

SECTION 1. There is hereby adopted and fixed a new salary/wage rates for certain municipal employees on Job Order Basis and further classifying their status thereof.

SECTION 2. Those appointed under the Job Order Basis shall be classified as follows and shall receive the following rates corresponding thereto; to wit:
