SPECIAL ORDINANCE NO. 06-10-22

SPECIAL ORDINANCE AUTHORIZING THE MUNICIPAL MAYOR TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE INSTITUTE FOR THE DEVELOPMENT OF EDUCATIONAL AND ECOLOGICAL ALTERNATIVES, INC. (IDEAS) REPRESENTED BY MINA C. BALLESTEROS, IDEAS MINDORO PROGRAM COORDINATOR IN CONSIDERATION WITH THE AMOUNT OF FIFTY THOUSAND PESOS (PHP50,000.00) GRANTED BY THE FORMER TO THE LATTER TO BE LIKewise CONTRIBUTED TO GELACIO I. YASON FOUNDATION FAMILY FARM SCHOOL AS FINANCIAL ASSISTANCE AND RATIFYING THE SAME CONTRACT

SECTION 1. The Municipal Mayor, Engr. Emilo C. Ballesteros, IDEAS Mindoro Program Coordinator in consideration with the amount of Fifty Thousand Pesos (Php50,000.00) granted by the former to the latter to be likewise contributed to Gelacio I. Yason Foundation Family Farm School as financial assistance; and to ratify the same contract;




