SPECIAL ORDINANCE NO. 06-10-21

SPECIAL ORDINANCE AUTHORIZING THE MUNICIPAL MAYOR TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH MA. CELESTE NEDIE LUMBO, PRESIDENT, KAPISANAN NG MGA KABATAANG NAGLILINGKOD (KAPISANKANA) GRANTING THE LATTER THE AMOUNT OF SEVENTEEN THOUSAND SIX HUNDRED PESOS (PHP17,600.00) AS FINANCIAL ASSISTANCE TO THEIR ATTENDANCE TO THE NATIONAL YOUTH DAY TO BE HELD IN DAVAO CITY AND RATIFYING THE SAME CONTRACT

Nedie Celeste Lumbo, President, Kapisanan ng mga Kabataang Naglilingkod (KAPISANKANA) for granting the amount of Seventeen Thousand Six Hundred Pesos (Php17,600.00) to the latter as financial assistance to their attendance to the National Youth Day to be held in Davao City and to ratify the same contract;
