SPECIAL ORDINANCE NO. 06-09-19

DECLARING JULY 15 OF EVERY YEAR AS "ARAW NG PAGTATANIM" IN THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO

BE IT ORDAINED by the Sangguniang Bayan of Bulalacao, Oriental Mindoro that:

Section 1. Statement of Policy. It is hereby declared the Policy of the Municipality of Bulalacao, Oriental Mindoro to require all national agencies and offices together with all branches of the Local Government Units, Non-Government and People's Organizations and other concerned sectors of the community to participate in rehabilitating our denuded forest and pursue strategies that shall regain the beauty of our ancient tropical forest; and likewise properties and limbs of the people as already experienced by other parts of the nation.

Section 2. Declaration of Policy. July 15 of every year is hereby declared as "Araw ng Pagtatanim" in the Municipality of Bulalacao, Province of Oriental Mindoro.

Section 3. Composition. This program shall be spearhead by the Local Chief Executive as Chairman in close coordination with the Community Environment and Natural Resources Office with the following as members;


- i. Municipal Agricultural Officer

- v. All Barangay Captains

- vii. SK Municipal Federation President


Section 4. After fifteen (15) days of its approval the members mentioned above are expected to convene in order to promulgate rules and regulations towards the effective implementation of this ordinance;

Section 5. This special ordinance shall take effect immediately.






