SPECIAL ORDINANCE NO. 06-04-10

CREATING THE POSITION OF MUNICIPAL ADMINISTRATOR, OFFICE OF THE MUNICIPAL MAYOR AND PRIVATE SECRETARY I, OFFICE OF THE MUNICIPAL VICE MAYOR IN A CO-TERMINOUS STATUS AT THE MUNICIPAL GOVERNMENT OF BULALACAO, ORIENTAL MINDORO

BE IT ORDAINED by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:

SECTION 1. There is hereby created in exigency of government service the following positions are hereby created in a co-terminous status according to the pleasure and trust of their respective appointing officer, to wit:

- i. Municipal Administrator shall receive the salary in accordance with the provisions of R.A. 7160 and applicable rules and regulations of the CSC.
- ii. Private Secretary I under the Office of the Vice Mayor. The same requirements with regards to salary as stated above shall be implemented corresponding to what the law provides.




SECTION 2. Effectivity. This Special Ordinance shall take effect upon approval.


