SPECIAL ORDINANCE NO. 06-04-07

SPECIAL ORDINANCE AUTHORIZING THE MUNICIPAL MAYOR TO ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT, REGION IV-B REPRESENTED BY MA. SUZETTE M. AGCAOILI, REGIONAL DIRECTOR FOR THE REHABILITATION OF BENLI FARM TO MARKET ROAD SITUATED AT BARANGAY BENLI, MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO

BE IT ORDAINED by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:

SECTION 1. In order to finish the rehabilitation of Benli Farm to Market Road, the Department of Social Welfare and Development Office, Region IV-B thru Barangay Benli Sub-Project Management Committee is hiring certain heavy equipments of the Municipal Government of Bulalacao to execute and finish the work mentioned herein;

SECTION 2. It is agreed upon that the KALAHI-CIDSS KKB Project shall pay all the necessary expenses incurred in carrying out the work which shall include the following:

- i. Salary of heavy equipment operators/mechanics (for an 8 hour/day)
- ii. Supply of petroleum, oil and lubricants
- iii. Cost of maintenance for the equipments

ENACTED this 3rd day of April, 2006, Bulalacao, Oriental Mindoro.






