**AMENDING ARTICLE L OF THE NEW REVENUE CODE OF 2004,
PROVISION ON MUNICIPAL CHARGES ON/AND USE OF HEAVY
EQUIPMENTS**

BE IT ORDAINED by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:

SECTION 1. Article L, Sec. 5L.03 is hereby amended by adding sub-sections (e)
and (f); to read as follows:

"SEC. 5L.03. ADMINISTRATIVE PROVISIONS. X X X :

X X X
e) A Memorandum of Agreement by and between the
Municipal Government of Bulalacao (Leassor) and the
Interested Party (Leassee) shall be required for the rentals
of heavy equipments in following conditions:


- i. Dumptrucks – 10 loads and above
- ii. Road Grader/Payloader/ Bulldozer - 8 hrs. and above


f) Hiring are only allowed within the jurisdiction of Bulalacao,
Oriental Mindoro.






