**ORDINANCE NO. 08-12-95**

**AN ORDINANCE AMENDING MUNICIPAL ORDINANCE NO. 08-07-85 DECLARING ACCESS ROAD FROM THE PROVINCIAL ROAD GOING TO BULALACAO PUBLIC MARKET ONE WAY TRAFFIC TO ALL TYPES OF VEHICLES AND PROVIDING PENALTIES IN CASE OF VIOLATION THEREOF**

**BE IT ORDAINED** by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:

**SECTION 1.** Access Road from Provincial Road going to Bulalacao Public Market, Bulalacao, Oriental Mindoro is hereby declared ONE WAY traffic to all types of vehicles. (Access Road is a Municipal Road 5 meters width and 24 meters length situated at Campasan, Bulalacao, Oriental Mindoro. The Sangguniang Bayan of Bulalacao has not yet been declared the official name of the Street).

**SEC. 2.** ONE WAY signboard shall be place on the entrance of abovementioned Access Road, and NO ENTRY Road Sign shall be installed on the opposite side left portion of the Access Road in Campasan, Bulalacao, Oriental Mindoro.

**SEC. 3.** An Ordinance or Ordinances in conflict and or inconsistent with this Ordinance is hereby repealed and modified accordingly.

SEC. 4. Violation of this Ordinance shall be fined of the following:

- First Offense - Php50.00
- Second Offense - Php100.00
- Third Offense and Subsequent Offenses - Php150.00

SEC. 5. This Ordinance shall take effect ten (10) days after posting.
