## SPECIAL ORDINANCE NO. 10-12-92

SPECIAL ORDINANCE ADOPTING P.D. 1096, OTHERWISE KNOWN AS THE "NATIONAL BUILDING CODE OF THE PHILIPPINES" IN THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO

BE IT ORDAINED by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:

**SECTION 1.** The provision of P.D. 1096, otherwise known as the "National Building Code of the Philippines" are hereby adopted to govern the construction, alteration, repair, conversion, usage, reoccupation, movement, demolition and addition of any building or structure in the Municipality of Bulalacao, Province of Oriental Mindoro;


**SEC. 2.** All ordinances inconsistent hereof are hereby repealed, modified accordingly;


**SEC. 3.** This Special Ordinance shall take effect ten (10) days after its posting;


