IMPOSING CHARGES FOR EVERY PRODUCT AND SERVICE RENDERED BY THE BULALACAO COMMUNITY E-CENTER

BE IT ORDAINED by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:

SECTION 1. There shall be collected the following charges for every product and service rendered by the Bulalacao Community e-Center; to wit:

SEC. 2. The charges herein imposed shall be paid to and collected by the Municipal Treasurer or his duly authorized representatives;

SEC. 3. Restrictions. Playing games, pornographic browsing, CD burning with protected intellectual property rights is restricted when using the services of the Bulalacao Community E-Center.

SEC. 4. Pursuant to Executive Order No. 2006-09-005 there is hereby created the Community E-Center (CeC) Core Group to manage, monitor and oversee the operation of the project which shall be composed of the following; to wit:

The duties and functions of this Core Group are stipulated in the herein mentioned Executive Order.











It is also understood that the members of the Core Group shall perform their tasks without receiving any honorarium.

SEC.5. Any violation of this Ordinance shall be punished by a fine of not less than Five Hundred Pesos (Php500.00) but not more than Two Thousand Five Hundred Pesos (Php2,500.00) or an imprisonment of not less than one (1) month but not more than six (6) months or both such fine and imprisonment at the discretion of the Court;


SEC. 6. This ordinance shall take effect upon the operation of the Bulalacao Community e-Center.
