SPECIAL ORDINANCE NO. 11-12-57

SPECIAL ORDINANCE AUTHORIZING THE MUNICIPAL MAYOR TO OPEN A NEW AND SEPARATE BANK ACCOUNT IN THE LAND BANK OF THE PHILIPPINES-CALAPAN CITY BRANCH EXCLUSIVE FOR THE OFFICE OF THE PRESIDENTIAL ADVISER FOR PEACE PROCESS (OPAPP) FUND INTENDED FOR BULALACAO, ORIENTAL MINDORO

BE IT ORDAINED by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:

SECTION 1. The Municipal Mayor, the Honorable Ernilo C. Villas is hereby authorized to open a new and separate bank account in the Land Bank of the Philippines-Calapan City Branch exclusive for the Office of the Presidential Adviser for Peace Process (OPAPP) fund intended for Bulalacao, Oriental Mindoro;


