SPECIAL ORDINANCE NO. 10-03-64

SPECIAL ORDINANCE DECLARING THE ENTIRE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO IN THE STATE OF CALAMITY TO EFFECT REMEDIES TO EL NINO PHENOMENON'S ENORMOUS DAMAGE AFFECTING THE AGRICULTURAL PRODUCTION GRINDING THE ECONOMY OF THE GENERAL POPULATION THEREON

BE IT ORDAINED by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:

SECTION 1. The entire Municipality of Bulalacao, Province of Oriental Mindoro is hereby declared to be under the State of Calamity in order to effect remedies to El Nino Phenomenon's enormous damage to agricultural production grinding the economy of the general population thereon;







SEC. 3. This Special Ordinance shall take effect immediately.


