CULLA, PRESIDENT, KAPISANAN NG MGA KABATAANG NAGLILINGKOD (KAPISANKANA) IN CONSIDERATION OF THE FIVE HUNDRED THOUSAND PESOS (PHP500,000.00) GRANTED BY THE LGU TO THE LATTER TO BE USED FOR THE FINANCIAL ASSISTANCE TO THE GRADUATES OF THE BTVC AND OTHER SKILLED WORKERS IN APPLYING JOBS ABROAD AND RATIFYING THE SAME AGREEMENT

BE IT ORDAINED by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:






**SEC. 2.** This Special Ordinance shall take effect immediately.
