SPECIAL ORDINANCE NO. 11-04-20

DECLARING THE MONTHS OF APRIL, OCTOBER AND NOVEMBER AS DEWORMING MONTHS IN THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO

SPONSOR: Honorable Emelita A. Osorio
CHAIRMAN: Committee on Social Services

BE IT ORDAINED by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:

SECTION 1. Declaration of Policy. It is hereby declared the policy of Bulalacao, Oriental Mindoro to promote sanitation, hygiene and principally the general health welfare of its inhabitants more particularly the health of children wanting of all the care and support from the government;

SEC. 2. Regulated Acts. The months of April, October and November of CY-2011 and year thereafter are hereby declared as Deworming Months for the Municipality of Bulalacao, Oriental Mindoro in order to achieve regular conduct of medical activities relative thereof;

SEC. 3. Creation of Special Committee. There is hereby further created a special composite committee to be known as Committee on Synchronized Deworming which shall undertake and perform the following;

- i. Shall administer and supervise all deworming activities for the children of the inhabitants of the Municipality of Bulalacao, Province of Oriental Mindoro;
- ii. Shall monitor and evaluate the necessary data collected to ensure that the health of this children fully attended to;
- iii. Shall determine the days and day of deworming activities in coordination with the barangay government concerned;

iv. Shall render report to the Office of the Municipal Mayor and Sangguniang Bayan containing therein recommendations, accomplishments and suggestions for the proper, effective and efficient implementation of this ordinance;


SEC. 4. Composition. The Committee herein created shall be composed of the following:


- Municipal Health Officer - Chairman
- Municipal Social Welfare and Development Office - Vice Chairman
- DepEd Representative - Members
- Bulalacao Community Hospital Representative - -do-
- Representative from the Sangguniang Bayan - -do-
- Pangulo, Liga ng mga Barangay - -do-
- Municipal Federation Pres., Sangguniang Kabataan - -do-
- NGO to be appointed by the Municipal Mayor - -do-


SEC. 5. Effectivity. This Ordinance shall take effect immediately.


