SPECIAL ORDINANCE NO. 11-04-19

SPECIAL ORDINANCE REQUIRING ALL PHILHEALTH BENEFICIARIES/ENROLLEES TO PLANT AT LEAST THREE (3) FRUIT BEARING OR DURABLE AND THREE (3) MALUNGGAY TREES ANNUALLY ON THEIR PRIVATE LANDS OR AREAS DESIGNATED BY THE GOVERNMENT FOR THE PURPOSE

BE IT ORDAINED by the Sangguniang Bayan of Bulalacao, Oriental Mindoro:


SECTION 1. In the furtherance of the environmental drive by this Municipality to preserve, protect and regenerate our forests and to promote backyard propagation of trees, it is hereby required that all PhilHealth beneficiaries/enrollees to plant at least 3 fruit bearing or durable and 3 malunggay trees annually on their private lands or areas designated by the government for the purpose.


SEC. 2. The Implementing Rules and Regulations shall be devised by the Office of the Municipal Mayor through the Municipal Social Welfare Office in coordination with the Municipal Agricultural Officer.


SEC. 3. This Special Ordinance shall take effect ten (10) days after its posting.






