**SPECIAL ORDINANCE TEMPORARILY CLOSING CERTAIN
 PARTS OF ATIENZA, PANTILO, BENDOLO AND TEMPLANZA
 STREETS IN POBLACION, BULALACAO, ORIENTAL MINDORO
 STARTING FROM JUNE 15, 2013 TO JULY 15, 2013**

BE IT ORDAINED by the Sangguniang Bayan of Bulalacao,
 Oriental Mindoro:

SECTION 1. In order to accommodate the selling of goods,

 the following streets mentioned hereunder are hereby temporarily closed
 from June 15 to July 15, 2013; to wit:

 Paz


