The meeting was called to order at 9:30 O'clock in the morning.

The calling of the roll was performed by the Recorder with the members answering present when their respective names were called.

The minutes of the previous meeting was also read by the Recorder and there no objection so on motion of Hon. Modesto O. Bacawag, seconded by Hon. Ulpiano C. Pandino, the minutes stand as confirmed.

All draft Resolutions requesting the chief Philippine Constabulary, Manila to provide this Municipality one service jeep and one fire truck to be used by the Police, Resolution requesting the General Manager, Philippine Charity Sweepstakes to provide the Municipality one ambulance; Resolution stopping the cutting of Mangrove trees outside the fishpond area of this Municipality; Resolution requesting the Schools Division Superintendent to return Mr. Edgardo L. Artiza to the District of Bulalacao; Resolution requesting Bgen Pacifico de Leon and Col. Victor Pagulayan Camp Aquinaldo, Quezon City for a supply of medicine and the Petition of the residents of Sitio Aplaya, this Municipality were read to this Body for comment.

Other Resolutions together with the Petition mention herof, were duly approved, except the Resolution returning Mr. Edgardo L. Artiza to the District of Bulalacao and promoting him to District Supervisor which is set aside for further study.

Vice Mayor Lazaro P. Visconde strongly objected to the enactment of the Resolution requesting the schools Division Superintendent for the return of Mr. Artiza to the District of Bulalacao on the ground that he had already measured the capability of Mr. Artiza in the construction of the Home Economics Building at the Central School, when Vice Mayor Visconde was the PTA President of this town. He said he has been asking for an audit of the expenses of the Home Economics building but Artiza paid no attention to his request until he left the District of Bulalacao. Hon. Visconde further said that its up for this body to approve the draft Resolution, but he is just voicing his opinion on the subject matter.

Hon. Ulpiano C. Pandino on the other hand said the matter must be set aside and that let other persons push Mr. Edgardo L. Artiza to that effect.

The SB Secretary was ordered by this Body to write Mr. Hilario Pamor, requesting him to remedy to the situation of the roof of this house which give damages to the Municipal road as reported by Hon. Modesto O. Bacawag in his privill-ges speech before this body ... UNANIMOUSLY APPROVED.

WHEREAS, the Police Force of this town has no service jeep and a fire truck to be used by them in emergency cases;

WHEREAS, considering the town of Bulalacao as the remotest place and a far flung Municipality in Oriental Mindoro, one Service jeep and one fire truck are needed by the Police for emergency cases;

NOW, THEREFORE, resolved as it is hereby resolved to request the Chief, Philippine Constabulary, Camp Crame, Quezon City to provide one service jeep and one fire truck to be used by the Police in this Municipality.

RESOLVED, FURTHER, that copies of this Resolution be furnished the Chief, Philippine Constabulary, Camp Crame, Quezon City for consideration and the Provincial Commander and the Sangguniang Panlalawigan, Calapan, Oriental Mindoro for their information and guidance.
