The meeting was called to order at 9:30 O'clock in the morning.

The calling of the roll was performed by the Recorder with the members answering present when their respective names were called.

The minutes of the previous meeting was also read by the Recorder and there no objection so on motion of Hon. Edilberto M. Pajila, seconded by Hon. Perpetuo C. Cantos, the minutes stands as confirmed.

Following the rules of procedure the meeting was suspended at 10:00 O'clock AM on motion of Hon. Modesto O. Bacawag, seconded by Hon. Wilfredo J. Eabile, to entertain some Barangay Captains in this Municipality who appeared personally before this body to present their respective problems regarding the release of the ₱5,000.00 for their barangay projects. Barangay Captains, Usig Garing of Benli, Miguel Panum of San Miguel said that their projects are not constructed due to lack of materials and the delay of the release of fund for the labor of said project. They said MLCGD, Melencio Faminialagao promised them to give the amount but until now, the same was not given to them.

In view of the above, Barangay Captains Usig Garing, Miguel Panum and Mar Astillo of Barangay Maasin Executed their respective affidavits stating the delay of the delivery of construction materials and the release of funds for the labor of said projects.

The SB Secretary was ordered by the Sangguniang Bayan to write Mr. Melencio Faminialagao to request the same to attend the Special meeting of this Body on May 20, 1981 for that purpose.

Two checks purposely for the maintenance of Municipal streets of this town amounting to ₱10,000.00 and ₱3,335.00 respectively was presented to this body by Mayor Dolores S. Bago. The town executive said the province also give ₱20,000.00 as Aid to the Municipality of Bulalacao for additional maintenance of Municipal Streets.
