The meeting was called to order by the Presiding Officer at 9:30 O' clock in the morning.

The calling of the roll was performed by the Recorder with the members answering present when their respective names were called.

The minutes of the previous meeting was also read by the Recorder and there no objection so on motion of Hon. Edilberto M. Pajila, seconded by Hon. Ulpiano C. Pandino, the minutes stands as confirmed.

The SB Secretary was instructed by this body to write all the Barangay Captains of this Municipality to attend the Regular meeting on April 27 in connection with an Ordinance requiring all the complainants in a certain case filed in the Barangay Justice Court to pay summons Fee to persons serving the summons.

RESOLUTION NO. 21

RESOLVED, to approve the following Ordinance:

ORDINANCE NO. 6

ORDINANCE

REQUIRING THE COMPLAINANT IN A CERTAIN CASE, FILED IN THE BARANGAY JUSTICE COURT IN THE MUNICIPALITY OF BULALACAO, ORIENTAL MINDORO TO PAY THE AMOUNT RANGING FROM ₱3.00 TO ₱5.00 AS SUMMONS FEE TO THE PERSONS SERVING THE SUMMONS DEPENDING ON THE DISTANCE COVERED THEREOF.

WHEREAS, the Barangay Justices of the Municipality of Bulalacao, Oriental Mindoro is financially incapacitated to maintain everything needed in the Office;

WHEREAS, different cases were filed in the barangay justice Court of this Municipality;

WHEREAS, these barangays has its own sitios which covered little distances from its barangay proper so it needs to hire persons to serve the summons;

WHEREAS, in view of the foregoing, the Sangguniang Bayan of Bulalacao, hereby Ordains that:

Section 1.- All complainants in a certain case filed in the Barangay Justice Court within the jurisdiction of the Municipality of Bulalacao are hereby required to pay the amount enumerated in the next preceding paragraph depending on the distances covered, as summons fee to persons serving the summons;

Section 2.- In the case of Barangays where the accuse is living within the Barangay proper the complainant should pay ₱3.00 as summons fee to persons serving the summons, while those living in a walking distance or outside the Barangay proper should pay ₱5.00;

Section 3.- Twenty (20%) percent of the above amount collected should go to the Office of the Barangay Justice Court for Office supplies while the rest will be given to persons serving the summons thereof;

Section 4.- Violation of this Ordinance or parts thereof, shall be punished by a fine of ₱25.00 to ₱200.00 or an imprisonment of 10 days to 30 days or both such fine and imprisonment at the discretion of the court;

Section 5.- Ordinance or Ordinances inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly;

Section 6. This Ordinance shall take effect immediately upon its approval.
