RESOLUTION NO. 18

REQUESTING THE REGIONAL DIRECTOR, MINISTRY OF EDUCATION AND CULTURE (MEC) REGION IV, QUEZON CITY, THROUGH THE SCHOOLS DIVISION SUPERINTENDENT, CALAPAN, ORIENTAL MINDORO TO GIVE NATIONAL AID FOR THE SALARIES OF NINE (9) HIGH SCHOOL TEACHERS OF BULALACAO, MUNICIPAL HIGH SCHOOL, BULALACAO, ORIENTAL MINDORO.

WHEREAS, at present there were nine (9) High School Teachers in Bulalacao Municipal High School, Bulalacao, Oriental Mindoro;

WHEREAS, of the NINE (9) High School Teachers mentioned above, only FIVE (5) of them were receiving salaries from the National Aid, while FOUR (4) of them were receiving salaries from the Municipal Government of Bulalacao, Oriental Mindoro;

NOW, THEREFORE, resolved as it is hereby resolved to request the Regional Director, Ministry of Education and Culture (MEC) Quezon City, through the Schools Division Superintendent, Calapan, Oriental Mindoro to give National Aid for the Salaries of four Teachers of Bulalacao, Municipal High School, Bulalacao, Oriental Mindoro.

RESOLVED, FURTHER, that copy of this Resolution together with the Plantilla of the nine (9) Teachers of Bulalacao Municipal High School, Bulalacao, Oriental Mindoro, be furnished the Regional Director, Ministry of Education and Culture (MEC) Region IV, Quezon City through the Schools Division Superintendent Calapan, Oriental Mindoro for their favorable and kind consideration....
