The Sangguniang Bayan of Bulalacao, on motion of Hon. Perpetuo C. Cantos,
seconded by Hon. Modesto O. Bacawag;

RESOLVED, to approve the following Ordinance:

ORDINANCE NO. 9 ✓

FURTHER AMENDING PARAGRAPH 1 & 2, OF SECTION 2 and SECTION 3 OF RESOLUTION NO.
16, ORDINANCE NO. 2, S. OF 1984 AND DECLARING F. ATIENZA ST., HEADING FOR TEM-
PLANZA AND A. SALAS STREETS, ONE WAY FOR ALL BUSES, JEEPNEYS and OTHER VEHICLES
ENTERING POBLACION

SECTION 1. F. Atienza St., heading to Templanza and A. Salas streets are
hereby declared one way for all, buses, jeepneys and other vehicles entering
Poblacion;

SECTION 2. Traffic sign boards shall be placed at points enumerated as
follows, to wit:

NO ENTRY	Along left side of A. Salas St. opposite corner of Atienza st. facing the Old Public Market.
THIS WAY	Along the corner of Atienza and A. Salas St.
UNLOADING/LOADING ZONES	Along the right side opposite Salas St. and the St. heading to Pier Arrestre.
THIS WAY TO PUB. MARKET	Corner of Salas St. and the st. heading to the Public Market.
NO PARKING	Along the Avenue of Salas St. purposely for passenger vehicles.

SECTION 3. A. Salas St. is designated One Way for all vehicles going out Poblacion;

SECTION 4. Names of all streets within Poblacion and road/street names shall be installed along corners;

SECTION 5. An outpost shall be constructed at the place opposite the corner of Atienza and Salas st. for INP Personnel to be posted thereat;

SECTION 6. Violation of this Ordinance or parts hereof, shall be fined the amount of P100.00 to P500.00 and an imprisonment of 10 to 30 days or both such fines and imprisonment at the discretion of the court;

SECTION 7. Ordinance or Ordinances inconsistent with the provisions of this Ordinance are hereby repealed or modified accordingly;

SECTION 8. This Ordinance shall take effect immediately;
