INQUIRING FROM THE COMMUNITY ENVIRONMENT AND NATURAL RESOURCES OFFICER, DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES, REGION IV, SAN MARIANO, ROXAS, ORIENTAL MINDORO THE STATUS OF AREAS LOCATED AT THIS MUNICIPALITY THAT WERE LEASED TO SOME PRIVATE PERSONS UNDER SO-CALLED PASTURE LAND LEASE AGREEMENT AND WHICH ARE ENROACHED AND OCCUPIED BY MEMBERS OF TAFARMA

"WHEREAS, a great vast of land located at this Municipality was leased by the government in favor of private individuals for purposes of sustaining and developing the country's dwindling cattle industry;

"WHEREAS, the Municipal Government was surprised upon learning that said areas were enroached upon by some individuals and settlements were established thereon;

"WHEREAS, the Municipal Government further wonders whether such establishment of settlement was done with proper permission from any competent authorities;

"WHEREAS, the Municipal Government is furthermore annoyed of this development as it becomes apprehensive of the possible collision of interests between the grantees and those persons who established settlements thereof;

"WHEREAS, it is imperative that this potential problem area be immediately investigated and addressed while it is still in the early period of development: Now, therefore, be it


areas located at this Municipality that were leased to some private persons under the so-called Pasture Land Lease Agreement and which are encroached and occupied by members of TAFARMA;




