"RESOLUTION NO. 95-10-070-A

REQUESTING THE REGIONAL DIRECTOR, DPWH, REGION IV-B THE CONCRETING OF 2 KM. BARANGAY ROAD FROM POBLACION TO BARANGAY MAUJAO AND 2 KM. FROM CAMPAASAN TO ODIONG, BULALACAO, ORIENTAL MINDORO

"WHEREAS, the Regional Office of the Department of Public Works and Highways (Region IV-B) sent a delegation of its personnels last year to conduct an investigation and survey of the conditions and status of roads situated at the Municipality of Bulalacao, Province of Oriental Mindoro particularly Poblacion to Maujao and from Campaasan to Odiong;

"WHEREAS, such delegation determined and informed the Municipal Government that the roads cited above are classified as national roads;

"WHEREAS, responsible persons from that delegation further informed the Municipal Government that there were funds allocated for the concreting of the said roads and such concreting would be caused by them in due time;

"WHEREAS, residents of this Municipality hailed such positive information as the concreting of these roads would facilitate the movement of goods and people as a result of this transportation program;

"WHEREAS, this Sanggunian, aware of the potential benefits that would redound to the people finds it proper and fitting to request the concerned government agency to release the allocation and implement the promised project on the earliest time possible; Now: therefore, be it



RESOLVED FURTHER, to let copies of this resolution be furnished the Regional Director, DPWH, Region IV-B, for his kindest approval;


