EARNESTLY REQUESTING THE HONORABLE MANUEL G. ANDAYA, CONGRESSMAN, 2ND DISTRICT, ORIENTAL MINDORO TO ALLOCATE THE AMOUNT OF ONE HUNDRED THOUSAND PESOS (P100,000.00) TO BE USED FOR THE CONSTRUCTION OF A WATER RESERVOIR IN BARANGAY CAMPAASAN, BULALACAO, ORIENTAL MINDORO

"WHEREAS, it is the thrust of the Municipal Government of Bulalacao, Oriental Mindoro to give the benefits of safe and adequate water supply to its constituents especially those in the rural areas, ensuring their good health and decreasing potential diseases that might be brought about by the lack of safe potable water;

"WHEREAS, Barangay Campaasan, this Municipality is presently experiencing insufficient water supply especially this summer season which brought discontentment and dissatisfaction among households of that barangay;

"WHEREAS, it is known that the scarcity of water in the abovementioned barangay is not due to lack of source but of infrastructural facility that of a water reservoir tank used to store water from the source before it be distributed to every household for their convenience;

"WHEREAS, the construction of the water reservoir tank is believed to ensure sufficient water supply at that barangay; Now, therefore, be it

RESOLVED AS IT IS HEREBY RESOLVED, To: Earnestly request the Honorable Manuel G. Andaya, Congressman, 2nd District, Oriental Mindoro to allocate the amount of One Hundred Thousand

Pesos (P100,000.00) to be used for the construction of a water reservior in Barangay Campaasan, Bulalacao, Oriental Mindoro;
