"RESOLUTION NO. 95-03-024

REALIGNING THE AMOUNT OF TWO HUNDRED THOUSAND PESOS (₱200,000.00) AID FROM SENATOR ALBERTO ROMULO'S COUNTRYWIDE DEVELOPMENT FUND (CDF) FOR THE CONSTRUCTION OF SHALLOW AND DEEP WELLS TO THE SPRING DEVELOPMENT PROJECT OF POBLACION, BULALACAO, ORIENTAL MINDORO

"WHEREAS, the benevolent senator, Hon. Alberto Romulo, allocated the amount of Two Hundred Thousand Pesos (₱200,000.00) from his CDF to the Municipality of Bulalacao, Oriental Mindoro and which was subsequently programmed by the Department of Public Works and Highways for the construction of Shallow and Deep Wells for this Municipality;

"WHEREAS, the previous construction of shallow and deep wells at the different component barangays of this Municipality had proven to be futile as the sources of water in the long run became scarce if not totally dry;

"WHEREAS, there is an on-going Spring Development Project being implemented by the municipal government in order to provide each and every household of Bulalacao, Oriental Mindoro with clean and potable water;

"WHEREAS, the residents of Poblacion, Bulalacao, Oriental Mindoro suffer from inadequate water supply not because of lack of source but of sufficient funds in developing the springs situated at this barangay;

"WHEREAS, it is only but practical, useful and immensely beneficial for the residents of this Municipality if the financial aid granted by the good senator (Hon. Alberto Romulo) be applied instead in the Spring Development Project at Poblacion, Bulalacao, Oriental Mindoro, Now therefore, be it:

RESOLVED AS IT IS HEREBY RESOLVED, That: The amount of Two Hundred Thousand Pesos (₱200,000.00) Aid from Senator Alberto Romulo's Countrywide Development Fund be realigned from the construction of Shallow and Deep Wells to the Spring Development Project of Poblacion, Bulalacao, Oriental Mindoro;







WHEREFORE, upon motion duly seconded, foregoing was . . .


