"WHEREAS, the Constitution provides that the State shall assign the highest budgetary priority to education and that basic and quality education be made accessible to all Filipino youths;

"WHEREAS, the Municipality of Bulalacao which is approximately composed of twenty percent Hanunuo Mangyans has made the initial steps of educating them through Scholarship Programs launched by the municipal government and still others are provided with Foster Parents to support them;

"WHEREAS, with the educational programs mentioned above, there are many Mangyans who graduated in secondary education however, most of them lost hope of continuing a college education because of financial incapability;


