EARNESTLY REQUESTING DR. BENJAMIN C. CRUZ, DIVISION SCHOOL SUPERINTENDENT, DEPARTMENT OF EDUCATION, CULTURE AND SPORTS, CALAPAN CITY TO PRIORITIZE THE CONSTRUCTION OF ONE (1) UNIT THREE-CLASSROOM SCHOOL BUILDING AT NASUCOB ELEMENTARY SCHOOL IN BARANGAY NASUCOB, MUNICIPALITY OF BULALACAO, ORIENTAL MINDORO AND ALLOCATING FUNDS THEREFOR

"WHEREAS, it is a Constitutional mandate that the State shall assign the highest budgetary priority to education and that quality education be made available to all;

"WHEREAS, Nasucob Elementary School in Barangay Nasucob, this Municipality is in dire need of an additional school building to house and accommodate the increasing enrollees every year;

"WHEREAS, at present, the temporary classroom used is made of light materials such as cogon and buri which poses danger to the lives and properties of the teachers and pupils alike particularly during the onslaught of bad weather condition;

"WHEREAS, it is also observed that there are 50 to 60 pupils in one classroom which should be 35 pupils only. This situation ruins a good educational system which states that quality education ensures all possible conditions for the fullest development of the pupils given the right opportunities and enough facilities to achieve educational goals; Now, therefore, be it

RESOLVED AS IT IS HEREBY RESOLVED, To: Earnestly request Dr. Benjamin C. Cruz, Division School Superintendent, Department of Education, Culture and Sports, Calapan City to prioritize the construction of one (1) unit three-classroom school



building at Nasucob Elementary School in Barangay Nasucob, Municipality of Bulalacao, Oriental Mindoro and allocating funds therefor;


