EARNESTLY REQUESTING THE HONORABLE EDGARDO J. ANGARA, SENATE CHAIRMAN, COMMITTEE ON EDUCATION, SENATE OF THE REPUBLIC OF THE PHILIPPINES TO ALLOCATE FUNDS FOR THE CONSTRUCTION OF THREE (3) CLASSROOM BUILDING FOR THE PROPOSED SOUTHERN BULALACAO NATIONAL HIGH SCHOOL, BULALACAO, ORIENTAL MINDORO

"WHEREAS, the Constitution acknowledged education essential to nation building and that the state shall give priority to education, science and technology, arts, culture and sports to foster patriotism, nationalism and development;

"WHEREAS, it further provides that the state shall assign the highest budgetary priority to education and that quality education be made available to all;


"WHEREAS, considering the fact that there is only one secondary school in the Municipality of Bulalacao, Province of Oriental Mindoro, the establishment of the Southern Bulalacao National High School is of great importance particularly to the five far-flung barangays who would directly benefit from it;

"WHEREAS, faced with financial constraint, being declared as Pro-Poor Municipality pursuant to Executive Order No. 370, the construction of three (3) classroom building at the proposed secondary school would only be realized through the benevolence of the good senator; Now, therefore, be it

RESOLVED AS IT IS HEREBY RESOLVED, To: Earnestly request the Honorable Edgardo J. Angara, Senate Chairman, Committee on Education, Senate of the Republic of the Philippines to allocate funds for the construction of three (3) classroom building for the proposed Southern Bulalacao National High School, Bulalacao, Oriental Mindoro;




