EARNESTLY REQUESTING THE HONORABLE RODOLFO G. VALENCIA, PROVINCIAL GOVERNOR AND CHAIRMAN OF THE PROVINCIAL SCHOOL BOARD, PROVINCE OF ORIENTAL MINDORO TO GRANT THE MUNICIPALITY OF BULALACAO WITH TWO HUNDRED FIFTY FIVE (255) ARMCHAIRS TO BE USED BY THE PUPILS AND STUDENTS OF TAFARMA ELEMENTARY SCHOOL AND MAUJAO NATIONAL HIGH SCHOOL RESPECTIVELY

"WHEREAS, the good governor noted for his being philanthropic would definitely merit this noble request; Now, therefore, be it




Elementary School and Maujao National High School respectively;
