"RESOLUTION NO. 99-04-073

EARNESTLY REQUESTING THE HONORABLE JUAN FLAVIER, SENATOR, REPUBLIC OF THE PHILIPPINES TO ALLOCATE THE AMOUNT OF FIVE HUNDRED THOUSAND PESOS (P500,000.00) TO BE USED FOR THE PURCHASE OF MEDICINES FOR THE INDIGENT RESIDENTS OF THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO

"WHEREAS, it is the prime duty of the State to protect and promote the right to health of the people and instill health consciousness among them;

"WHEREAS, it is sad to note that residents of this Poor Municipality could hardly cope up with their basic needs particularly access to affordable medicines and basic medical services;

"WHEREAS, cognizance of the welfare of the constituents against the attack of fatal and contagious diseases such as dengue and malaria which causes injuries and deaths, the Municipal Health Office of this Municipality conducted comprehensive health programs in the far-flung barangays however, appeared to be futile without the provision of sufficient medicines and available medical equipments;


"WHEREAS, hounded with financial constraint the Municipality of Bulalacao, Oriental Mindoro could not readily augment the appropriation for the purchase of medicines needed for the maintenance of good health and prevention and control of diseases; Now, therefore, be it




(P500,000.00) to be used for the purchase of medicines for the indigent residents of the Municipality of Bulalacao, Province of Oriental Mindoro;


