"WHEREAS, the residents of Sitio Sta. Rosa, Barangay San Juan of this Municipality are in dire need of School site where they could send their children for education;


"WHEREAS, residents are in need for site to which school building can be erected, and the sitio noted above is located in a place classified as forestal area at a moment;
