AUTHORIZING THE MUNICIPAL MAYOR TO ENTER THE AGREEMENT WITH NATIONAL FOOD AUTHORITY TO PURCHASE RICE ON CREDIT FROM THE NATIONAL FOOD AUTHORITY (NFA)

"WHEREAS, NFA is identified to be the national government's agency to be charged with among others, ensuring the nation with enough supply of grains;

"WHEREAS, Republic Act No. 7160 vested the local government units with authority to discharge the functions and responsibilities of some national agencies powers devolved unto them;


"WHEREAS, envisioning the immediate assistance to populace the local government units and the National Food Authority (NFA) made an agreement to provide the former with necessary aid;


"WHEREAS, the same law (RA 7160) stated that the local chief executive shall be allowed to enter into contract only upon authorization by the legislative council;

RESOLVED AS IT IS HEREBY RESOLVED, To: Authorize the Municipal Mayor to enter into an Agreement with the National Food Authority to purchase rice on credit to supply the future demand of Bulalacao Community.


