"RESOLUTION NO. 97-07-107

REQUESTING THE HONORABLE RODOLFO G. VALENCIA, PROVINCIAL GOVERNOR TO ALLOCATE FUNDS FOR THE REHABILITATION OF THE WATER SYSTEM AT SITIO CAVILLAN, BARANGAY NASUCOB, BULALACAO, ORIENTAL MINDORO

"WHEREAS, water plays a vital role in sustaining man's life and preserving their good health by decreasing potential diseases that might be brought about by the lack of potable water;

"WHEREAS, there is an existing water system at Barangay Nasucob, this Municipality, however, due to blockage and defective pipelines it could not fully serve the residents at Sitio Cavillan who are forced to get water from any available source, where there is no assurance of its potability;

"WHEREAS, there is a dire need to repair or change the pipelines coming from the water source to Sitio Cavillan in order to provide safe drinking water to its inhabitants;


