" RESOLUTION NO. 97-05-080

APPROVING THE BARANGAY FUND ANNUAL BUDGET FOR FY 1997
OF BARANGAY NASUCOB, BULALACAO, ORIENTAL MINDORO APPROPRIATING THE AMOUNT OF FIVE HUNDRED SIXTY THREE THOUSAND THREE HUNDRED NINETY EIGHT PESOS AND NINETY CENTAVOS (P563,398.98) PASSED UNDER SANGGUNIANG BARANGAY APPROPRIATION ORDINANCE NO. 1, DATED JANUARY 6, 1997

"WHEREAS, Section 57 and Section 447 par (1i) empower the sangguniang bayan to review all ordinances passed by the sangguniang barangay to determine whether these are within the scope of the prescribed powers of the sanggunian and not to be inconsistent with law or municipal ordinance;

"WHEREAS, the Sangguniang Barangay of ~~Nasucob~~ Bulalacao, Oriental Mindoro submitted its Barangay Fund Annual Budget for FY 1997 showing therein the sources of income and the barangay expenditures starting January 1, 1997 up to December 31, 1997;

"WHEREAS, the Barangay Fund Annual Budget for FY 1997 of Barangay Nasucob was duly taken up by the Sangguniang Bayan of Bulalacao, Oriental Mindoro in the regular session held on May 19, 1997 with the following recommendations:

- i. The programs and projects under the 20% Development Fund should be in accordance with Memorandum Circular No. 96-263 entitled "Policies and Guidelines on

the Utilization of the Twenty Percent (20%) Development Fund and Related Matters;

- ii. That the 20% of the 20% Development Fund should be utilized to finance programs that address Human and Ecological Security (HES);
- iii. The disbursements of appropriations shall be guided by existing COA rules and regulations ; Now, therefore, be it

RESOLVED AS IT IS HEREBY RESOLVED, To: Approve the Barangay Fund Annual Budget for FY 1997 of Barangay Nasucob, Bulalacao, Oriental Mindoro appropriating the amount of Five Hundred Sixty Three Thousand Three Hundred Ninety Eight Pesos and Ninety Eight Centavos (P563,398.98) passed under Sangguniang Barangay Appropriation Ordinance No. 1, dated January 6, 1997; subject to compliance with all existing laws, rules and regulations;
