AUTHORIZING THE MUNICIPAL MAYOR TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH MISTER BENJAMIN H. SALAS FOR THE CONSTRUCTION OF WATER SYSTEM SITUATED AT SITIO TULALE, BARANGAY POBLACION, THIS MUNICIPALITY

"WHEREAS, the Municipal Government takes cognizance of the need to develop a new water system to arrest the worsening water crisis in the barangays of Poblacion and Campaasan;

"WHEREAS, there is a spring situated at Sitio Tulale, Poblacion in a lot owned by Mr. Benjamin H. Salas which he is willing to share with the Municipal Government;

"WHEREAS, the construction of a water system out of Tulale Spring would definitely redound to the benefits of the residents of Bulalacao, more particularly to those living at Barangay Poblacion; Now, therefore, be it

RESOLVED AS IT IS HEREBY RESOLVED, To: Authorize the Municipal Mayor to enter into a Memorandum of Agreement (MOA) with Mister Benjamin H. Salas for the construction and development of a Water System in Sitio Tulale, Barangay Poblacion, this Municipality;

RESOLVED FURTHER, To: Further authorize the Municipal Mayor to hire a caretaker the moment the water system becomes operational. Such caretaker may be entitled to

a monthly compensation in the amount of Three Thousand Pesos (P3,000.00);




