" RESOLUTION NO. 97-04-075

APPROVING THE BARANGAY FUND ANNUAL BUDGET FOR FY 1997 OF BARANGAY SAN JUAN, BULALACAO, ORIENTAL MINDORO APPROPRIATING THE AMOUNT OF FOUR HUNDRED SEVEN THOUSAND SEVEN HUNDRED FIFTY THREE PESOS AND SEVENTY ONE CENTAVOS (P407,753.71) PASSED UNDER SANGGUNIANG BARANGAY APPROPRIATION ORDINANCE NO. 97-01, DATED MARCH 9, 1997

"WHEREAS, Section 57 and Section 447 par (1i) empower the sangguniang bayan to review all ordinances passed by the sangguniang barangay to determine whether these are within the scope of the prescribed powers of the sanggunian and not to be inconsistent with law or municipal ordinance;

"WHEREAS, the Sangguniang Barangay of San Juan, Bulalacao, Oriental Mindoro submitted its Barangay Fund Annual Budget for FY 1997 showing therein the sources of income and the barangay expenditures starting January 1, 1997 up to December 31, 1997;

"WHEREAS, the Barangay Fund Annual Budget for FY 1997 of Barangay San Juan was duly taken up by the Sangguniang Bayan of Bulalacao, Oriental Mindoro in the regular session held on April 28, 1997 with the following recommendations:

- i. The program and projects under the 20% Development Fund should be in accordance with Memorandum Circular No. 96-263 entitled 'Policies and Guidelines on the Utilities of the Twenty Percent (20%) Development Fund and Related Matters;

- ii. That the 20% of the 20% Development Fund should be utilized to finance programs that address to Human and Ecological Security (HES);
- iii. The disbursements of appropriation shall be guided by existing COA rules and regulations; Now, therefore, be it

RESOLVED AS IT IS HEREBY RESOLVED, To: Approve the Barangay Fund Annual Budget for FY 1997 of Barangay San Juan, Bulalacao, Oriental Mindoro appropriating the amount of Four Hundred Seven Thousand Seven Hundred Fifty Three Pesos and Seventy One Centavos (P407,753.71) passed under Sangguniang Barangay Appropriation Ordinance No. 97-01, dated March 9, 1997;
