REQUESTING THE BUREAU OF FISHERIES AND AQUATIC RESOURCES (BFAR) TO GRANT FINGERLINGS OF TILAPIA INTENDED FOR THE LIVELIHOOD OF FISHERFOLKS OF THE MUNICIPALITY OF BULALACAO, THIS PROVINCE

"WHEREAS, the main sources of living of the constituents of Bulalacao, Oriental Mindoro are neither farming nor fishing with which great percentage belongs to the latter;

"WHEREAS, knowing that our ocean is so abused that it almost yields no catch to our marginal fishermen, some fishing methods are now being encouraged to provide the lowly- Filipino with the descent social living such as tilapia farming; Now, therefore, be it
