"WHEREAS, the provision of street lights at the abovementioned barangays would definitely defer the movements of various criminal elements and malicious intents inclined to occur during night time;


"WHEREAS, it is believed that the installation of street lights would not only lessen criminalities but likewise provides convenience to the residents;
