REQUESTING THE PHILIPPINE HEALTH INSURANCE CORPORATION, REGIONAL HEALTH INSURANCE OFFICE, REGION IV-B TO ACCREDIT THE BULALACAO COMMUNITY HOSPITAL SITUATED AT THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO AS MEDICARE HOSPITAL

"WHEREAS, it is understood that the accreditation of a hospital to adopt the Medicare sa Masa Program requires at least two (2) permanent physician, the Bulalacao Community Hospital at the Municipality of Bulalacao, Oriental Mindoro is requested to be an exceptional case for the benefits of the indigents and the senior citizens;

"WHEREAS, presently, the Bulalacao Community Hospital is manned by only one physician however, the Sangguniang Bayan of Bulalacao by virtue of Resolution No. 00-12-174 requested the Honorable Rodolfo G. Valencia to fill-up the vacant position of Medical Officer III in order to be accredited as a Medicare Hospital;

"WHEREAS, the Municipal Government of Bulalacao, Oriental Mindoro in support to the Medicare sa Masa Program appropriated the necessary amount for the implementation of the project that would definitely benefit its indigent residents particularly the senior citizens and the Hanunuo Mangyans;


