**REQUESTING THE PROVINCIAL ENVIRONMENT AND NATURAL RESOURCES OFFICER, DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES, CALAPAN CITY TO CONDUCT INVENTORY OF THE REMAINING FOREST RESOURCES AND TO FILE CHARGES IF NECESSARY AGAINST ANY PERSON VIOLATING FORESTRY LAWS AT BUYAYAO ISLAND, MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO**

**"WHEREAS,** the Local Government Units are task to adopt strategies and policies and promulgate necessary ordinances to protect, conserve and preserve the remaining natural resources which are crucial in maintaining a balanced ecology;

**"WHEREAS,** it is with sad displeasure to see that a place like Buyayao Island which is considered a local treasure is wantonly destroyed, abused and exploited by despicable persons, further the acres of woods have been robbed by thieves of its natural resources knowing that those persons aggravated the crime for being intruders to the area, coming from other towns so to speak;

**"WHEREAS,** considering all the potentials of such place which is arguably a haven to both local and foreign tourists and the corresponding income that might be generated it is incumbent therefore for the LGUs and the national agencies specifically the DENR to commit themselves in working together in order to preserve the verdant and natural scintillating beauty of the Island of Buyayao which is often visited by both local and foreign tourists as well as those who belong to academe; Now, therefore, be it

**RESOLVED AS IT IS HEREBY RESOLVED, To:** Request the Provincial Environment and Natural Resources Officer, Department of Environment and Natural Resources, Calapan City to conduct inventory of the remaining forest resources and to file charges if necessary against any person violating Forestry Laws at Buyayao Island, Municipality of Bulalacao, Province of Oriental Mindoro;




