EARNESTLY REQUESTING THE PHILIPPINE HEALTH INSURANCE CORPORATION, REGIONAL HEALTH INSURANCE OFFICE, REGION IV-B TO ACCREDIT THE BULALACAO COMMUNITY HOSPITAL LOCATED AT THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO AS PHILHEALTH HOSPITAL

“WHEREAS, it is understood that the accreditation of a certain hospital to adopt the Medicare Para sa Masa Program under the National Health Insurance Program (NHIP) requires at least two (2) residents physicians however, in consideration for the welfare of Philhealth beneficiaries which are composed mostly of the indigents and the senior citizens, it is requested that the Bulalacao Community Hospital be an exceptional case;

“WHEREAS, the Municipal Government of Bulalacao, Oriental Mindoro in its effort to provide basic health services to its constituents appropriated the necessary amount to grant their membership to NHIP but seems to be useless on account that the only hospital at the locality is not accredited as the Philhealth hospital;


“WHEREAS, to facilitate the matter, the Sangguniang Bayan of Bulalacao, Oriental Mindoro passed a resolution requesting the Provincial Governor to immediately fill-up the position of Medical Officer IV at the Bulalacao Community Hospital;

"WHEREAS, rainy season is the time for the widespread of various diseases so that our poor Philhealth beneficiaries would suffer the difficulties of travelling to the nearest Philhealth hospital at Mansalay, Oriental Mindoro; Now, therefore, be it




