COMPARED TO OTHER SUPPLIERS**

"WHEREAS, the delivery of basic health services has been devolved to the Local Government Unit by virtue of Section 17 of Republic Act 7160 otherwise known as the Local Government Code of 1991;

"WHEREAS, the Municipality of Bulalacao cognizance of the good health of its people undertake various programs and strategies to maintain and promote the good health of its constituents that it is believed that the availability of sufficient medicines is equally important;


"WHEREAS, to achieve its goal, the Municipal Government of Bulalacao appropriated a certain amount for the purchase of medicines that it is lately known that medicines from the Philippine Trading Corporation (PTC) are almost fifty percent (50%) lower in price compared to other suppliers;

"WHEREAS, in consideration to the need to acquire more medicines to sustain the demand of the people, it appeared to be economical and practical if those be purchased from the PTC; Now, therefore, be it

RESOLVED AS IT IS HEREBY RESOLVED, To: Request the Honorable Gemma G. Salas, Municipal Mayor, Bulalacao, Oriental Mindoro to purchase medicines from the Philippine Trading Corporation (PTC), Manila for it is cheaper compared to other suppliers;


