EARNESTLY REQUESTING THE HONORABLE EDGARDO J. ANGARA, SECRETARY, DEPARTMENT OF AGRICULTURE TO GRANT THE AMOUNT OF FIFTEEN MILLION PESOS (P15M) FOR THE GRAVELLING OF BALATASAN HIGH WAY AT THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO

"WHEREAS, the Municipality of Bulalacao, Province of Oriental Mindoro was declared as a Pro-Poor Municipality pursuant to Executive Order No. 370;

"WHEREAS, the Balatasan Highway which is approximately 11.5 km. away from the national road remains unpassable during rainy season that hinders the socio-economic development of that barangay dueto the difficulties in the shipment of various agricultural and marine products;


