RESOLUTION NO. 05-05-075

AUTHORIZING THE MUNICIPAL MAYOR TO ACCEPT THE DONATED PARCEL OF LAND SITUATED AT BARANGAY CAMBUNANG, BULALACAO, ORIENTAL MINDORO UNDER ORIGINAL CERTIFICATE OF TITLE NO. P-3400 CONTAINING AN AREA OF 30,399 SQUARE METERS TO BE USED AS SITE FOR GAWAD KALINGA HOUSING PROJECT

"WHEREAS, through the generosity of Engr. Rodolfo Dayanghirang, Rommel Dayanghirang, Melany Dayanghirang, Renan Dayanghirang, and Melissa Dayanghirang, the Municipality of Bulalacao became recipients of thirty thousand three hundred ninety nine (30,399) square meters by virtue of a Deed of Donation executed on 31st day of December, 2004 at Roxas, Oriental Mindoro for the exclusive used for the site of Gawad Kalinga Project and shall not be used to any purposes;






