IDENTIFYING AND PRIORITIZING THE CONSTRUCTION OF FARM TO MARKET ROAD FROM THE NATIONAL HIGHWAY TO SITIO GATOL, BARANGAY SAN ROQUE AT THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO, ALLOCATING THE AMOUNT OF FIVE MILLION PESOS (Php 5M)

“WHEREAS, Sitio Gatol at Barangay San Roque, Municipality of Bulalacao, Province of Oriental Mindoro is located approximately two (2) km. away from the national highway is composed of almost 100% hanunuo mangyans who because of poverty and lack of education are considered to be at the lowest ladder of socio-economic strata;


