### RESOLUTION NO. 09-10-144

**EARNESTLY REQUESTING HER EXCELLENCY GLORIA MACAPAGAL ARROYO, PRESIDENT, REPUBLIC OF THE PHILIPPINES TO INCLUDE IN THE 2010 BUDGET THE AMOUNT OF ONE HUNDRED FIFTY MILLION PESOS (PHP150M) TO BE USED FOR THE COMPLETION OF THE MINDORO EAST COASTAL ROAD TRAVERSING IN THE MUNICIPALITY OF BULALACAO, PROVINCE OF ORIENTAL MINDORO TO THE PROVINCE OF OCCIDENTAL MINDORO**

“WHEREAS, under Section 25 of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991 pertaining to the national supervision over LGU says that “consistent with the basic policy on local autonomy the President shall exercise general supervision over LGU to ensure that their acts are within the scope of their prescribed powers and functions and that the President may, upon request of the LGU concerned direct the appropriate national agency to provide financial, technical or other forms of assistance to the LGU such an instance shall be extended at no extra cost to the LGU concerned”;

“WHEREAS, citing the rationale by the Local Chief Executive of this Municipality that Bulalacao place a very significant role not only in MIMAROPA but also in the country's arterial road networks and that the construction of Mindoro East Coastal Road shall promote economic growth geared towards the realization of shared interests, aspirations and dreams;

“WHEREAS, the completion of the abovementioned road that shall connect the Provinces of Oriental and Occidental Mindoro shall open the floodgates of trade and commerce between the two provinces and other southern islands of Panay and Mindanao, promote tourism industry, enhance mutual understanding and strengthen love and nationalism; Now, therefore, be it

**RESOLVED AS IT IS HEREBY RESOLVED, To:** Earnestly request Her Excellency Gloria Macapagal Arroyo, President, Republic of the Philippines to include in the 2010 Budget the amount of One Hundred Fifty Million Pesos (Php150M) to be used for the completion of the Mindoro East Coastal Road traversing in the Municipality of Bulalacao, Province of Oriental Mindoro to the Province of Occidental Mindoro;
