## RESOLUTION NO. 09-10-142

**RESOLUTION AUTHORIZING THE HONORABLE ENGR. ERNILO C. VILLAS, MUNICIPAL MAYOR TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE NATIONAL STATISTICS OFFICE (NSO) FOR THE USE OF THE BREQS-LGU SYSTEM**

**"WHEREAS**, the National Statistics Office through the Civil Registry IT (CRS-IT) Project has established on-line Census Serbilis Centers (Serbilis Outlet) in various locations of the Philippines to serve points for the decentralized servicing of request for civil registry documents for the public;

**"WHEREAS**, the Local Government Unit of Bulalacao, Oriental Mindoro, through the Office of the Municipal Civil Registrar is receiving and servicing requests for civil registry documents registered in this municipality and is also interested in providing a more extensive service to its constituents not only for documents registered in the municipality but also those that may have been registered in other localities, as well as constituents from nearby island municipalities;

**"WHEREAS**, the NSO has developed the BREQS-LGU System which provides for an off-line method of encoding requests for civil registry documents and submission thereof to an on-line Serbilis Outlet of the NSO;

**"WHEREAS**, a resolution authorizing the Honorable Engr. Emilo C. Villas, Municipal Mayor, enter into a Memorandum of Agreement (MOA) with the National Statistics Office (NSO) for the use of the BREQS-LGU System is indispensably necessary;




